Genevieve Collins BA (Hnrs), LLB, GAICD Deputy Chair

Genevieve has been the Chief Executive Partner (managing partner) of law firm Lander & Rogers since 1 July 2018. As Director of Policy, Rachel led the establishment of the National Mental Health Commission in 2011 where she joined with SANE Patron Janet Meagher AM to develop the Contributing Life Framework. She was the author of Australia's first national consumer paid participation policy, and produced the first National Report Card on Mental Health and Suicide Prevention in 2012. Prior to joining SANE, Rachel was CEO of a medium sized mental health and disability NGO. She also designed and led large scale community suicide prevention implementation efforts around Australia in her role at the Black Dog Institute, including LifeSpan – the systems approach to suicide prevention. Rachel has also held senior roles in mental health, business development and public health policy with the

Department of Prime Minister and Cabinet, the Department of Health and Care Connect. Rachel holds academic qualifications in human geography, political economics, leadership and management, and has held non-executive director roles with Being, the Institute of Analytics Professionals Australia, Sands Australia, Red Nose and the NSW Cycling Women's Commission.
